102/06/17.C Parish Clerk's Progress Report

Report/update from Divisional Surveyor

All highway reports from the last meeting have been reported through the Oswestry Office. Update from Chris Fisher at highways is as follows;

1. The footpath behind the Institute in Green Lane, St Martins was now impossible to walk along in certain places with adjacent hedges required to be cut back. Response - We will investigate & cut this back (if there are birds nesting in the hedges we'll wait till after the nesting season). Cllr's said this was undergrowth on the footpath.

2. The damaged road sign in Clarkes Lane had still not been replaced, a drain cover has been lifted up on a number of occasions out onto the road and there is an increase of litter along this lane. Response - We will investigate & see if we can fix the drain cover down & arrange for this to be litter picked. Cllr's reported that this sign has now been repaired.

3. Cllr's requested a sign for Moors Lane Chapel to be erected on the Main Road. *Response - We have no funding for this*. Cllr's suggested we should contact Shropshire Council Tourism Department to see if they have a budget for this.

4. The road markings had still not been replaced at the end of Cottage Lane and lines in Coopers Lane and Bradford Lane required re-painting. *Response - We will investigate & add it to the lining program if necessary.* Now been established that this will be done.

5. It was reported that the ditch opposite Orchard Close had still not been dug out. *Response - We will investigate & check the flooding implications*. Cllr's said that enforcement action should be taken against the developers as this was part of the conditions including road markings and planning officers should check that all these conditions are being met.
