## 165/07/17.C Public Participation

Sue Heard one of the Trustees from the Community Centre gave a presentation on their project to 'Keep Everyone Safe' in the centre and surrounding area. This included updating the CCTV with additional cameras to ensure full coverage of all areas around the building and working with Stan's Superstore to install additional cameras to cover the field behind Stan's. Cllr's had expressed concern over the amount of litter being left in this field.

Other improvement work for the centre included re-laying the paths in front and side of the building plus making the temporary path from the car park permanent with additional drainage and some gardening work including reducing the height of some of the scrubs to ensure good visibility for visitors and cameras. New litter and recycling bins will also be provided. Fund raising events have already commenced to part fund this project.

Sue agreed to keep the parish council updated on this project. The Chairman thanked Sue for her report who then left the meeting.

### 172/07/17.C Parish Clerk's Progress Report

All highway reports from the last meeting have been reported through the Oswestry Office. Updates from Chris Fisher are as follows;

- 1. Fly tipping in Fach Lane and tyres being dumped in Clarkes Lane. *Ringway have been given an order to pick up fly tipping / tyres this should have been done.*
- 2. Footpath up Moors Bank now has hedge and tree branches overhanging it in places. *Inspection will be done on hedge / tree branches on footpath up Moors Bank if this is an issue it will be cleared.*
- 3. The road breaking up on the St Martins side of Escob Bridge. We will inspect & monitor the road at Escob Bridge. Cllr's felt this should read 'repair' and not 'monitor' and the Divisional Surveyor will be notified of this change.
- 4. A large pot hole adjacent to no's 43 & 44 Moors Bank. *Ringway have been given an instruction to fix pothole at 43/44 Moors Bank.*

# **173/07/17.C Police Report**

The police had sent their apologies but a report of incidents during June had been circulated. Cllr J. Stevens expressed concern that the new format of reporting incidents does not mean anything and that the police should go back to the original format of reporting crime figures.

With regards to the Police & Crime Commissioner John Campion attending our September meeting it was agreed to forward the following questions to him prior to the meeting; (1) ensure that monthly crime figures are set out in a list of statistics that tell us about what crimes are going on in our parish and where and not of meaningless set of graphs, (2) enforcement of speed limits, (3) future level of police officers especially in rural areas should a proposed merger take place with other emergency services and (4) easier ways of extending speed limits in our village.

There will also be a ten minute session for the Cllr's and public to raise questions.

174/17 C.JULY.17

**To consider** any planning application issues that have arisen since the last meeting and decisions on planning appeals.

Cllr's then considered the following email from Nick Scott of J Ross Developments.

I wished to give you and the Parish Council advanced warning that we intend to remove two short sections of hedge (clearly indicated in the attached report) in line with our planning permission, where the foot path from our scheme is due to connect with the public footpath on the Overton Road. In advance of this work we have commissioned an ecological report from our consultant to ensure that we are not interfering with nesting birds, which I attached for your information. I expect that the works will co-inside with a road opening notice, required to complete electrical diversions in the public footpath outside the site which we have also routed through these sections of hedge, these are likely to take place within the next 10 working days. I trust these arrangements are in order, however if you or your Councillors have any queries please do not hesitate to contact me.

Although this was in-line with the planning conditions Cllr's questioned the time lapse since the study was done and notifying the parish council on the 7th June and whether another study was required. After further discussion is was agreed to make no comment.

# 176/07/17.C Transfer of Services/Amenity Sites.

Cllr's noted a report from the Parish Clerk on a recent meeting of the Town and Parish Council Forum. The Parish Council are now in discussions with Shropshire Council on whether to take on the responsibility for maintaining some of the amenity areas in the village. At present possible cut backs in Shropshire Council budgets might result in these areas not being maintained to the standard we expect. Firstly the parish council will be looking at the specification for this work including having some flexibility over the number of cuts per year taking into account weather and growing conditions. Further updates will be given so that hopefully all residents will support the action being taken by the Parish Council.

### 177/07/17.C Shropshire Council

Cllr's noted correspondence received from Shropshire Council since the last meeting.

Shropshire Cllr Steve Davenport reported that Shropshire Council would supply a litter Bin for Windy Ridge for £185. However the annual cost for emptying the bin by their contractor Ringway will be £300. He added that they could not remove or transfer an exchange for the redundant one at Ifton School.

175/17 C.JULY.17

Shropshire Cllr Steve Davenport reported that bollards will be installed along the Overton Road at its junction with Ellesmere Road to stop vehicles parking on the grass verges in October.

Shropshire Cllr Steve Davenport also reported that he is having further discussions with highway officers over improvements to the mini island junction of Ellesmere Road and Overton Road. One option is to retain the existing mini-roundabout and create an overrun area to make it easier for large vehicles turning left from the Overton Road into Ellesmere Road. The other option would be to remove the existing mini-roundabout and realign the junction to create a staggered crossroads with the main priority route being the St Martin's to Ellesmere route and vice versa.

Cllr's expressed concern over the lack of maintenance to the surrounding area of Ifton School.

Cllr Steve Davenport

Cllr D. Laing suggested we have at least 2 flashing VAZ signs in the village, the ones that smile at you when you are doing 30 mph or under along the Overton road in the heart of the village. Shropshire Cllr Steve Davenport agreed to look into this and report back.

As regards the Orchard Close Development the Chairman expressed concern because for some time it has been our concern that pre-site conditions had not been met by the property developer of Orchard Close, St Martins, 'land west of Cottage Lane'. Failure to produce white line markings, excavate drainage ditch, noticeable sewage smell, and capping of the outlet vents near the electricity pylon (and public footpath) further down Cottage Lane. We have repeatedly asked Planning for information about site enforcement and your reply has been a deafening (and embarrassing) silence. Shropshire Cllr was asked to follow this up as a matter of urgency.
