153/07/16.R Urgent Items

The Chairman and Cllr S. Schofield reported on a recent meeting with the RoSPA Inspector during his visit on the 29th June 2016 to carry out the

Action

Annual Inspection of the Play Areas. The results of this visit had been reported back to the Parish Council/St Martins Centre Contracts Review at their meeting on the 30th June which will be presented to Council at the July meeting along with the detailed RoSPA report. However the inspector's conclusion was that the most likely cause was misuse of the gate. The inspector suggested a number of options for consideration, the one favoured being to replace the gate with a fixed metal fence of the same type used around the skate park but set at 90 degrees to the perimeter fence.

It was proposed by Cllr S. Schofield, seconded by Cllr B. Herbert and carried that the Parish Clerk obtains a quotation for two new posts for the sign on Stan's Field. The Parish Clerk was also asked to clarify through Ray Parry Playgrounds the fitting recommendations for the spinner.

154/07/16.R Rhosyllan Farm Recreation Area

The Chairman updated Members on this proposed recreation area. As regards the Section 106 agreement a number of questions raised by the applicant's solicitor with Shropshire Council have now been resolved. The application is still going through the planning process. However the Chairman stressed that it was important and urgent that members of the public put their names forward to join a working group to look at this open space.
